

**General Meeting of the
Duval County Council of PTAs/PTSAs

Call to Order

The first area would be greater improvement in reading starting from Pre-K to 3rd Grade. Second is further improvement in graduation rates. Third would be to continue to work on the gap closure particularly with the students on free and reduced lunch. He stated that it needed individual follow through-through response to intervention. Lastly, moving forward in strategic partnerships and engaging big businesses in Jacksonville. He mentioned that we needed to get those businesses on board in providing support especially in turnaround schools. He continued to say that there was a lot of progress in a lot of areas but it still needs a lot of work.
