Florida was named one of sixteen State finalists for the Race to the Top stimulus grant money. Representatives from the State will travel to Washington, D.C. for more information and to find out about the next phase of the process. Other grants are also being worked within the district, including the School Improvement grant and the Investing in Innovation grant.

Last Tuesday, the DCPS Board members spoke at the City Council meeting. The City Council members have now been invited to attend the board workshop scheduled for March 30 at the Schultz Center at 3:30 p.m. The next City Council meeting will be held on April 13, and we may need a strong parent

presence at that meeting to make sure they know that we do not want our school board members appointed by the Mayor because it takes away our right to elect our community leaders.

Budget meetings are currently going on around town. The first meeting at Sandalwood High School had a great turnout. The next meeting is tonight at Ed White High School, followed by Ribault High School and Mandarin High School. She encouraged everyone to attend.
