

## DCCPTA Award Information



The Duval County Council of PTAs/PTSAs believes many local units are doing outstanding work. The Council initiated an Achievement Award in 1970-1971. Over the years the Council has continued to add awards to recognize the wide variety of outstanding work being done by the local units in Duval County.

### Criteria for Award Applications

#### 1. PTAs/PTSAs must be "IN GOOD STANDING" which means:

- Local Unit **BYLAWS** have been approved by Florida PTA every **3 years**. (Check date stamp on front page)
- Duval County Council PTA **DUES** have been paid for the current school year.
- State & National PTA Membership **DUES** have been paid by March 1 of the current school year.
- File the appropriate 990 form with the IRS by November 15.
- Register your PTA officers with Florida PTA.
- Submit a copy of your Annual Audit for the prior fiscal year to Florida PTA at **Audit@floridapta.org** and to the DCCPTA Treasurer at **Treasurer@dccpta.org**.

#### 2. Correct Usage of PTA service mark:



Additionally, failure to use the PTA service mark correctly will keep your awards and historian entry from being judged. You MAY NOT use periods, commas, hyphens, or lowercase letters when referring to PTA. This is in keeping with the Florida PTA and National PTA guidelines. This information may be found in the National PTA kit of materials.

#### 3. DEADLINES for awards applications must be met. Please note that applications can be mailed in to the Awards Chair or brought to monthly DCCPTA meetings. You do not have to wait for the final deadline to turn in award applications if you have met the criteria early.

- DCCPTA Deadline for ALL awards applications:
  - **Date:** At or before the **April DCCPTA General Meeting, by NOON**
  - **Place:** Bring ID to enter School Board Building, Cline Auditorium.
  - **Deadline Exceptions noted in ( ) on following page.**
- Florida PTA Deadlines:
  - **Membership Awards:** Applications and supporting material **MUST** be IN the Florida PTA office by March 31. Most Florida PTA awards may **NOT** be FAXed in.
  - **All other Awards:** **MUST** be IN the Florida PTA office **by May 1**. Most Florida PTA awards may **NOT** be FAXed in.

### Tips for Award Winning Applications

- Please use current application forms as they are updated every year.
- Applications will be rejected if directions are not followed.
- Fill in all blanks completely.
- Give the correct local unit name. (See your Local Unit approved Bylaws.)
- DEADLINES. Late applications are **NOT** accepted.
- Be sure to include name and phone number of a contact person (usually the President).

**Automatic Award Given to the one PTA with the most hours volunteered.**

**History Awards** *From the entries submitted, 1<sup>st</sup> 2<sup>nd</sup> and 3<sup>rd</sup> will be awarded based on Grade-Level Divisions.*

**PTA of the Year:** *must apply for the Local Unit Achievement Award to be considered. One award per Grade-Level Division.*

### GRADE-LEVEL DIVISIONS

- **Small Elementary** (schools up to 5<sup>th</sup> grade only): **up to 750 students** per "20-day enrollment count"
- **Large Elementary** (schools up to 5<sup>th</sup> grade only): **751 students** and over per "20-day enrollment count"
- **Middle or combined Elementary/Middle** (schools with grades 6-8 **or** K-8)
- **High or combined Elementary/Middle/High** (schools with grades 9-12, 6-12, **or** K-12)
